




The 7th Biennial Conference on Developmental Disabilities: Health & Wellbeing across the Lifespan

DESCRIPTION

The term developmental disabilities (DD) refers to people with intellectual disability, autism spectrum, fetal alcohol spectrum and related neurodevelopmental genetic syndromes. Children, youth, and adults with DD are vulnerable to high rates of general health and mental health concerns. This interactive 2020 conference will focus on practical strategies to optimize the quality of life for people with DD. Our goal is to help clinicians and caregivers learn effective ways to work with people with DD, and their families, in partnership to improve their quality of life experience. The conference will also provide educational and informative psychiatric, behavioural, mental health, and complex physical health updates specific to people with DD, and showcase best practices in the field. This conference will engage health care providers and educators from a wide range of professional disciplines in knowledge transfer and interdisciplinary collaboration.

Reimaging Community Inclusion in the Midst of a Global Pandemic

British Columbia, like most jurisdictions, excluded individuals with developmental disabilities (DD) for decades by housing them in large institutions. Since the closure of those institutions, self-advocates, with the support of their families, have pursued inclusion and belonging. They helped the government form Community Living BC in 2005, a crown corporation with a mandate to provide a range supports that complement family and community supports. In 2018 Minister Shane Simpson launched the Reimaging Community Inclusion (RCI) initiative to engage and consult a broad range of stakeholders to assess the current status of inclusion and to determine the priorities for the next ten years. The RCI Leadership Group was re-established in early 2019 with the mandate of advancing inclusion priorities related to housing, employment, health, and support for Indigenous Peoples with DD. The CEO of Community Living British Columbia will share some of the learnings of the past, lessons learned during the COVID-19 pandemic, and discuss the opportunity to advance meaningful inclusion for individuals with DD.

The focus of this presentation will be on ageing in people living with Down Syndrome, the need to offer an individualized approach, especially to treatment, and the sometimes thorny question of autonomic dysfunction (low heart rate, constipation, bladder difficulties, impaired standing balance) that commonly accompanies and sometimes precedes dementia, which can go with that. The focus will be how to interpret what is being seen including distinguishing between what signs of neurodegeneration are and what might be ordinary willfulness.
